

DOG ELIGIBLE TO ENTER

This trial is open to all dogs SIX (6) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP). Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) number must be spayed or neutered in order to compete. Wherever the word "dog" is used in these regulations it includes both sexes.

Dogs with physical challenges (including amputees) are eligible to participate provided that, in the opinion of the judge, the dog displays no sign of physical discomfort and can safely complete the search. Deaf and blind dogs are allowed to enter. Females in season may not participate, aggressive dogs, or dogs suffering from an injury, or illness which may affect the dog's physical or mental performance may not participate. No dog shall compete if it is sutured, bandaged, or has any visible wounds.

WAIT LIST INFORMATION

GRCA is offering a wait list for the Detective class to fill openings created by withdrawn entries after the trial's closing date/time. A maximum of **25 entries** will be placed on the club's wait list. All entries, including wait listed entries, must be received by the Trial Secretary prior to September 4, 2024 12:00 pm. No entries may be withdrawn with a refund after closing on September 4, 2024 12:00 pm. If a withdrawn entry is replaced by a wait listed entry, a full refund will be issued for the withdrawn entry. Checks will be shredded for any wait listed entry that does not move off the wait list into the trial.

STAGING AREA, HANDLER'S BRIEFING, AND WARM-UP INFORMATION

A **warm-up area** will be available consisting of ONE marked container of each odor being tested at the trial and may also consist of blank containers. Exhibitors should limit their warm-up to (2) two minutes or less. The warm-up area is to be used exclusively for warming up the handler-dog team prior their run. The warm-up area is not for training or relieving of the dog.

Staging Area will be out of view of search area(s). Staging area will include warm-up and waiting area, as well as the secretary table for check-ins and posting of running order and results.

The **Handler's Briefing** will take place at the start line with the judge. The judge will explain if there's an off-leash option, number of hides, maximum height of hides and maximum time for the search.

SEARCH AREA AND RING CONDITIONS

Search areas may be of any shape, and of the size specified in the Regulations for each class.

Search Area Conditions. Searches may be indoors on blue rubber matting, or concrete, or outdoors on grass, gravel, earth, concrete, or asphalt surfaces.

ADDITIONAL SITE INFORMATION

Trial Site. It is not appropriate to visit the trial location prior to the trial date. Many search locations are real-life environments and such visits may risk the host losing the opportunity to use the location in the future. This trial site will not be used for Scent training one week before the trial

Possession of Odors and Training. Chapter 5. Section 26 of the Scent Work Regulations state "No person other than those engaged in the administration of a trial shall be in possession of any target odor when on the trial grounds. There shall be no training on the grounds of the AKC Scent Work trial, other than the designated warm-up area".

Spectator Area. This will be left up to each judge.

Crating space. There will be designated crating areas, but be prepared to walk to search areas.

Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available at various locations around the show grounds.

Reactive dogs

Chapter 3 Section 30. Special Accommodations for Certain Dogs. Clubs are not to make special accommodations for certain dogs (such as dogs determined by their owners to be "reactive"). Clubs may not advertise a "red bandana" policy in Premium lists or printed materials or impose such a policy in the briefing.

From the South - Take I-91 North to Springfield - Exit 3, Mile 4 (Sign reads "Route 5, Columbus Ave., Agawam, West Springfield"). Follow Route 5 North to Route 147 West, then proceed as above.

From the East or West - Take Mass. Pike (I-90) to Exit 4, Follow signs marked "Route 5, Riverdale St., West Springfield". Take Route 5 South to Route 147 West, and then proceed as above.



NOTICE TO EXHIBITORS

SAFETY, BEHAVIOR and LIABILITY

The safety of the dog is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all searches safely. It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. GRCA and its agents, employees, etc., will assume no responsibility for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children. GRCA reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against GRCA or any official thereof.

Collars, Leashes and Harnesses. During searches, dogs must wear a properly fitted collar or harness approved by the judge. A wearable camera such as a Go Pro may be mounted to the dog's harness, if desired. Leashes may be of any length and/or retractable. The leash should be made of plain, pliable material.

All dogs must be on leash at all times, and retractable leashes may not be used when on trial grounds (except during judged searches). Dogs must enter and exit the search area with the leash attached to the collar or harness, including when waiting in the search area before and after the search. An off-leash option may be offered at the discretion of the judge, only if the area is completely enclosed.

REFUNDS

No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee. Dogs pulled after closing because of injury or other medical condition are not eligible for a refund.

Bitches in season will be refunded the full entry fee. Notification in writing must be given to the trial secretary no later than one half hour prior to the start of the first class of the day of the trial.

RINGSIDE

Judges are not required to wait for dogs. The Owner of each dog is solely responsible for having it ready at the search area when it is to be judged. The Club has no responsibility to provide service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

CONFIRMATION OF YOUR ENTRY: You will receive a confirmation email of your entry with an armband number at least one week before the trial closes. Check over your confirmation for any corrections needed. You will receive a schedule at least one week before the trial dates. If you do not receive a confirmation email, notify the secretary before the trials closing date.

EXHIBITOR CHECK-IN: Once the time and location for check-in is determined all exhibitors will be notified by email.

Claims will be arbitrated as set forth on the Official AKC Entry Form for this event.
