As required by the AKC Tracking Regulations, a written certification must accompany the TD or TDU entry for any dog which has not previously passed an AKC TD or TDU test.

All entrants submitting certifications should enclose a self-addressed stamped envelope so that unused certifications may be returned.

In accordance with Chapter 1, Section 12 of the Tracking Regulations, the Test Secretary may enter and handle a dog that she owns or co-owns.

No dog may be entered in more than one test on each day. However, under Chapter 1, Section 11, a dog may be entered in more than one test at a combined tracking test where each test is held on a separate day in conjunction with a National Specialty.

SUBSTITUTION OF TRACKS: In the event that there are insufficient TD or TDX entries or insufficient TDU or VST entries, tracks may be substituted using the factor of 2 TDs = 1 TDX and 2 TDUs = 1 VST as specified in Chapter 1, Section 15 of the AKC Tracking Regulations.

The drawings for entries and alternates will be conducted in accordance with Chapter 1, Section 17 of the AKC Tracking Regulations. These TD/TDU/TDX/VST Tests are limited to Golden Retrievers.

The drawing will take place at the test secretary's home at 8:00 AM on Thursday, September 5, 2024 or as soon as practicable thereafter, however if the Secretary is entered the drawing will be conducted by another member of the tracking committee. After the entry limit is reached in TD, TDU, TDX or VST, an alternate list will be prepared with positions assigned according to the order in which they were drawn. The Test Secretary will notify all entries of the results of the draw by e-mail as soon as practicable after the draw.

WITHDRAWALS: Withdrawals must be made in writing to the Test Secretary. If an entry withdraws for any reason between the closing date and the test date and is replaced by an alternate, the entry check will not be used, however, if the entrant is not replaced by an alternate the check will be used. The entry check for an alternate that does not participate will not be used.
